HB 1156	C 192 L 09	Alternative route program	Anderson	Creates a preference in the alternative route teacher certification programs for veterans and National Guard members.
SHB 1170	C 502 L 09	Parenting plan modification	McCoy	 Addresses changes to custody decrees and parenting plans when a parent is unable to exercise residential time or visitation with a child because of the parent's military duties. Provides that any change in custody as a result of the custodial parent's military duties shall be temporary. Allows a court to delegate the residential time or visitation of a military parent to a person other than a parent during the military parent's absence. Requires the court to hold expedited hearings and allow testimony by electronic means when the military parent cannot appear in person.
HB 1478	C 159 L 09	Deployed military personnel	Orcutt	Deployed military personnel are able to renew their vehicle registrations and have the registration year start on the date that the expired license is renewed so that the renewed license will be useful for an entire 12-month period. To be eligible, the registered owner must: be a member of the United States armed forces; have been stationed outside of Washington under military orders during the prior vehicle registration year; and provide the DOL with a copy of the military orders.

				 Eliminates the requirement that members make contributions for interruptive military service upon return to state service if that service is during a period of war. ESHB 1906	C3L09	Unemployment compensation	Conway	Provides for a temporary increase in unemployment benefits by adding \$45 to the weekly benefit amount, and making \$155 the minimum amount payable weekly. Eliminates restrictions on the shared work program on the number of an employer's employees that must be enrolled, and the number of weeks that such employees may receive benefits. Provides for non-charging of the additional \$45 and training benefits.

SSB 5248	C 380 L 09	Military children	Hobbs	 Enacts the Interstate Compact on Educational Opportunity for Military Children (Compact) with certain amendments. Amends certain current education laws to achieve consistency with the Compact. Requires the State Council, which is created by the Compact, to review implementation of the Compact and, by December 1, 2014, to recommend to the Legislature whether the state should continue membership in the Compact.
SSB 5270	C 369 L 09	Voter registration	McDermo tt	Among other changes: The definition of "service voter" is expanded to include any elector of the state of Washington who is a member of a reserve component of the armed forces.
SSB 5481	C 56 L 09	Veterans' burials	Marr	Any deceased veteran or veteran's dependant that is left unclaimed for a period of 90 days or longer, and is certified by the DVA as eligible for internment at a federal or state veterans' cemetery, may be transferred from the person or entity in possession of such human remains to the custody of the DVA. The person or entity transferring the human remains to the DVA is immune from any liability associated with such transfer. The state, its employees, and agents are also immune from any liability related to the transfer of such human remains to the DVA.

SB 5739	C 59 L 09	Concealed pistol license	King	The \$10 penalty, for renewal of a CPL after expiration, does not apply to members of the armed forces who are serving outside the state of Washington when his or her CPL expires. Application for renewal must be made within 90 days of returning to Washington State.
